

New investments given green light at WBIF 4th Operational Board

WBIF Operational Board members gave a positive opinion on 30 June in Oslo, to 14 new investments flagships in transport, energy, environment, human capital, and private sector support in the Western Balkans, worth €2.1 billion. The European Commission contributes with €528 million in EU grants from the IPA III, whilst the rest is provided by bilateral contributions from EU Member States and Norway, loans from international financing institutions, and contributions from the economies of the Western Balkans. In addition, a total of 11 technical assistance grants totalling €11.2 million were green-lighted to prepare project investments.



New skills for new rails

The Albanian government's Ministry of Infrastructure and Energy has made the shift back from road to rail a national priority. The Albanian railway company HSH (Hekurudha Shqiptare) has been asked to help turn things around by promoting an ambitious programme to rebuild and modernise the railways. The plan would make transport in Albania greener, more competitive and more sustainable, and improve connections with neighbouring countries and the trans-European railway network.

Grant agreement for the solar plant in Oslomej signed

The European Union and WBIF bilateral donors, together with the European Bank for Reconstruction and Development (EBRD), are consolidating their support for solar energy projects in North Macedonia with grant financing for the first large-scale solar plant. A WBIF bilateral donor grant agreement of €1.6 million was signed on 30 June 2023 in Skopje, complementing an EBRD loan of €5.9 million.

Works to begin on school building upgrades for energy efficiency

The Ministry of Capital Investments in Montenegro launched a call in July 2023 for works to upgrade the energy performance of schools across the country. The project is financed with a €4.8 million grant from the Regional Energy Efficiency Fund (REEP+), through the WBIF and a loan of €45 million from German development bank KfW. The Government of Montenegro also provides €10 million of its own funds.

The EU grant agreements to the value of €17.1 million were signed 22 May 2023 at the Council of Ministers premises in Sarajevo, Bosnia and Herzegovina (BiH). The new funds will target the ongoing construction of the country's major transport road corridor and improving the water supply system in City of Visoko and surrounding settlements.
